DISCUSSION:

Reliable operation of the heat supply system is essential to ensure good quality life for the citizens. Elimination of emergency risks during the heating season is an important task for relevant organizations and really should be part of the state policy. For this, timely and well-coordinated preparation of the heat supply companies, heat grid companies, and heat consumers for the heating season.

Today, the municipal-housing and heat-energy sectors face difficulties associated with the consumers being unsatisfied with the quality of the services they get. What's more, the industry is still using the standard-based charging method, as heat energy metering units are not used widely enough. Besides, the heat supplying system infrastructure and the heat receiving equipment at the consumer end lack investment.

According to the data provided by the Russian Federal Statistics Service, over 30% of heat networks have to be replaced, which is about 50 thousand kilometers of pipes.

The main reason behind such a high percent of grids in unsatisfactory condition is ineffective budget allocation in regions and municipalities.

The participants of this event will talk about the urgent issues and possible ways of solving the problems associated with outages in reliable heat supply to consumers.

STRATEGIC SESSION

DIFFERENTIATED TARIFFS IN THE ELECTRIC ENERGY INDUSTRY: RISKS AND OPPORTUNITIES

DISCUSSION:

At least for last 20 years, the citizens in most of the Russian regions have been undercharged for the electric energy they use, whereas industrial consumers have to pay extra to energy producers and providers for the latter to keep the municipal tariffs low through the cross-subsidies mechanism.

The very idea of letting the citizens pay for electric energy at a special price is natural for any socially focused government. On the other hand, without proper control regulations on the part of the regional agencies and regulation bodies, those who were not entitled to use this privilege somehow managed to start using it. As a result, disreputable business people, who had connected to the mains illegally and who are consuming electricity on a commercial scale, as well as extensive households that can be classified as luxurious pay for what they use at a special price intended for the citizens. Differently speaking, they are making the state budget and the industrialists to share their expenses and pay for them. Thus, minor businesses like locksmiths', metal and wood workshops arranged in old barns, bath houses, illegal mining farms, villas with heated swimming pools, alleys, and parking lots have the industry or the state pay for the electricity they consume.

The participants of the event will talk about one of the most pressing matters of the electric energy industry, which is efficiency of cross-subsidies.

- How cross-subsidies hamper economic development of Russia.
- Who actually pays for illegal mining, shady business people, and heated swimming pools.
- · How pseudo-privilegees are a threat for wallets of common consumers.
- · Regions where differentiated tariffs have been introduced just to check the box.
- · What can really help to break the tether of cross-subsidies?

During the event, the talkers will try to answer these and other questions. Experts from Energy Consumers Association will present a review on the tariff campaign results in the Russian regions and talk about effective mechanisms that can be used to reduce the cross-subsidies amount and yet retain special prices for those who really need them.
